Motion:

A motion was made by Mr. Furgess and seconded by Col. Leaks to authorize legal counsel to proceed with an investigation and keep in mind that unnamed personnel is innocent of these charges.

Mr. Anderson asked Attorney Heizer what the next steps should be. Attorney Heizer stated that this substitute motion would replace the original motion. She requested that the Board provide legal counsel with further information, specifically if they were authorized to associate a third party independent law firm to assist in the investigation.

Mr. Furgess amended his previous motion to state:

Motion:

A motion was made by Mr. Furgess and seconded by Col. Leaks to authorize a third party hired by the law firm to proceed with an investigation and keep in mind that unnamed personnel is innocent of these charges.

Mr. Anderson restated the motion to say:

A motion was made by Mr. Furgess and seconded by Col. Leaks to authorize Burr Forman to proceed with an investigation by hiring a third-party attorney to pursue the investigation keeping in mind. that these are allegations and the unnamed party is innocent until proven quilty.

Representative Howard asked if this would be a partial investigation or all the allegations. It was confirmed that it would be all the allegations. It was discussed and Mr. Anderson's version was the more appropriate motion because the phrase "innocent until proven guilty" was used.

Mr. Green expressed his unhappiness of the use of the employee's name in the original motions as this is a personnel issue. It was discussed and determined that the name would be redacted from the recording and not reflected in the minutes.

Mr. Anderson requested we take the name out of the minutes.
