1. CALL TO ORDER AND DETERMINATION OF QUORUM

Col. Leaks called the meeting to order at 12:01 P.M. A quorum was confirmed at the opening of the meeting.

Mr. Furgess requested to make a motion to move Item 10A on the agenda up to after Number 5 on the agenda.

Ms. Dickerson said this motion is out of order as the agenda itself should be adopted first. This was confirmed by Attorney Baker.

Attorney Heizer suggested having Mr. Furgess make his motion then proceed to approve the amended motion as amended or as written.

ADOPTION OF AGENDA

Mr. Furgess made a motion seconded by Dr. Morris to move Item 10A to right after Number 5 on the agenda.

10. A. ACCEPT ATTORNEY GENERAL OPINION (item moved per motion)
Col. Leaks suggested making a motion to adopt the Attorney General's opinion.

Motion:

A motion was made by Mr. Furgess and seconded by Dr. Morris to move that we the COMET Board accept the Attorney General's Opinion as rendered to the COMET on September 8, 2020 and respond accordingly. In this case, responding accordingly includes our Legal Team informing all concerned municipalities that they are not MEMBERS of the Central Midlands Regional Transit Authority, but might apply to become a member by following the procedures and intent as outlined in SC Code Section 58-25-10 thru 58-25-100, and with subsequences approval by the COMET Board of Directors.

Mr. Anderson requested the page numbers corresponding to the motion and asked Attorney Heizer to summarize the topic.

Attorney Heizer explained that the opinion dated September 8, 2020 is in response to the questions submitted on behalf of the Authority. She further explained that the Attorney General's office made reference to an opinion dated January 6, 2014. She added that the January 6, 2014 opinion stated to become a member of the Authority,



a municipality must have a population of five thousand (5000) or more persons. She explained that concept is mentioned again in the most recent opinion and also in a footnote.

Attorney Heizer referred to the memo and explained that she respectfully disagrees with that analysis. She stated that she and Attorney Baker have reviewed the legislation and are confident that when the original legislation was adopted, the word "cities" appeared. She continued that the word "cities" can be defined as municipalities with 5000 or more persons.

1997 language was amended to replace the word "cities" with "municipalities." She further stated that municipality is defined as counties within the unincorporated areas of the service area of the authority. The municipality is defined as an incorporated city or town within the service area. She continued to state that she believes this was intended to allow incorporated towns with a population of less than five thousand (5000) to become members of an authority.

Attorney Heizer informed the Board of a call from the Attorney who drafted this opinion. He explained they have revisited the language and tracked the legislative history as we defined it, and they are going to revise their opinion. She verified that going forward the Attorney General will not opine that of an incorporated municipality as having a population of five thousand (5000) persons to become a member.

Attorney Heizer explained that she and Attorney Baker intend to give the best legal advice as possible. She did state the uncertainty of the receipt of something in writing.

After Point of Order and debate over discussion time before the vote of the motion, Representative Howard Called the Question and it was seconded by Dr. Morris. Mr. Green requested a point of parliamentary inquiry. Mr. Green wanted clarity of the number of votes, 2/3 majority in order to pass the Call the Question.

Attorney Heizer explained that when a motion for the previous question is made, it closes the debate but 2/3's vote or unanimous consent is required to end the debate. The motion itself is not debatable.

Attorney Baker confirmed that the vote on the floor is to the Call the Question.

Mr. Anderson asked Attorney Heizer to explain the Attorney General response regarding municipalities and does it impact their status on Advisory Board. Attorney Heizer did not respond as Col. Leaks told Mr. Anderson that he is Out of Order.

Discussion ensued regarding the political subdivisions, service areas and the application process.
