Subject: Central Midlands Regional Transit Authority Fiscal Year 2022-23 Proposed Budget

Requested Action: Staff recommends that the Board of Directors approve adoption of Fiscal Year 2022-

2023 proposed Operations and Capital budget.

<u>Background and Summary</u>: RTA law 58-25-70 states Central Midlands Regional Transit Authority present a budget within 60 days to the member governments prior to the fiscal year and they need to adopt it.

SECTION 58-25-70. Recordkeeping and reporting; proposal and approval of budgets.

<u>Fiscal Impacts:</u> An overall decrease to total operating and capital revenue and expenses by \$5.55M or 12% from fiscal year 2021-2022. The decrease is largely in part due to reduction of Cap X revenue (line 28) and expense (line 90). Cap X accounts are for purchases of large capital expenditures such as buses. In the upcoming fiscal year, we do not anticipate purchasing any new rolling stock. The large increase in professional services is for related Intermodal Center and hydrogen bus projects.

Red numbers indicate a reduction in that line item and a Green number indicates an increase.

Legal Counsel Review: None.

Recommended Motion: Board of Directors approve adoption of the proposed Fiscal Year 2022-2023 Operations and Capital budget.
